

General Information and Tour Conditions

DEPOSITS AND PAYMENTS:

Your reservation deposit of \$250 (\$175 is nonrefundable) per person is official upon receiving your check.

The payment schedule is as follows:

- Initial deposit of \$250 due at time of reservation
- Final payment of balance due 90 days before departure.

Cruise Fare:

Rates are per person based on double occupancy, and include the cruise fare, meals on board the ship, entertainment, and activities. Passengers under age 21 must share the cabin with a relative over the age of 25.

CANCELLATIONS:

All cancellation requests must be submitted in writing and addressed to A & M Travel, Inc. Failure to appear for embarkation for any reason constitutes a cancellation subject to full penalties. Cancellation penalties will be charged as follows:

IMMIGRATION:

U.S. and Canadian citizens must carry a passport. A Birth Certificate or Social Security card are not acceptable as proof of citizenship. Aliens who are permanent residents must have their Alien Registration Card and passport. All other non-U.S. passengers should contract their respective embassies or U.S. Immigrations for applicable regulations. Boarding will be denied to those without proper documentation. Children under age 16 do not require a photo I.D.

NOT INCLUDED:

Gratuities will be charged to your sign and sail card on board the ship. Taxes, fuel charges and fees are subject to change. In the event of an increase in fuel costs, a surcharge will be applied to your sail and sign account.

In the event of strike, lockouts, riots or stoppage of labor from whatever causes, or for any other reason whatsoever beyond the control of A & M Travel or Carnival, Carnival in its sole discretion may cancel, advance, or postpone any scheduled sailing or call at any port and may (but is not obligated to) substitute another vessel, and neither Carnival nor A & M Travel shall be liable for any loss whatsoever to passengers by reason of such cancellation, advancement, postponement, or substitution.

Carnival, A & M Travel, and Booking group expressly disclaim any responsibility for personal injury or property damage arising out of the acts or negligence of any air carrier, hotel, or any other person rendering any of the services offered in addition to the ship's cruise and shall not be responsible for any damage or inconvenience caused by late air, car or motor coach arrivals, cruise cancellation or delays in departure or return, nor for loss or damage to baggage, automobiles, or other property of the passenger occurring off the vessel. Neither Carnival, A & M travel, nor booking group, nor their respective owners, agents, officers, or employees shall be liable for illness, accident, death, dismemberment, weather, strikes, acts of God, terrorist acts, or the accessibility, appearance, actions, or decision of any persons or entities promoted for this cruise.
